Withdrawal of Access 1400 and Non-barcoded Parcel and GLL Services

Dear Customer,

We wrote to you in September 2023, to inform you we will be withdrawing a number of non-barcoded services, as well as the Access 1400 service for Parcels and GLLs as part of our barcoding strategy.

The withdrawal will be implemented over two phases as follows:

1. **From 3 April 2023** Access 70 and Access 1400 non-barcoded Parcel services will be withdrawn. For the avoidance of doubt, we will continue providing Access 70 and Access 1400 non-barcoded services for GLLs after 2 April 2023. We have already issued contract change notices which will effect these changes;
2. **From 2 January 2024** Access 1400 Parcel and 1400 GLL services will be withdrawn. The appended Parcels Contract Change Notice, Access Letters User Guide Amendment and Parcels User Guide Amendment gives effect to the withdrawal of these services.

The table at Annex A provides a breakdown of the services which will be withdrawn as per the above phases.

We have also published the list of product codes which are due to be withdrawn on the [Royal Mail Wholesale website](#).

We will continue to keep you engaged on progress against our barcoding strategy.

i. *Paragraph 6 of Appendix M of this User Guide shall be deemed amended to read as follows:*

“You must ensure each Mailing Item within a Mailmark Mailing:

a. has a Mailmark Barcode printed on it in addition to any other marks that are required for the Access 70 Mailing Item in question;


b. has a Mailmark Barcode printed on it in a manner and location and in accordance with the specifications, as set out in the Mailmark Letters and Large Letters specification below.”

- 3.3 All of the rules about how to interpret the Contract shall apply to this notice.

4 Changes to the Contract

- 4.1 Under clause 13.2.1(d) of the Parcels General Terms and Conditions of the Contract we hereby notify you of the following changes to the Parcels User Guide:
- 4.1.1 Section 1 shall be amended as follows:

1 Overview of Parcels Services

This User Guide must be read in conjunction with your Contract. Together these documents govern the terms on which you may obtain access to our Inward Mail Centres. Our Parcels Services enable you to hand over Mailing Items at an Inward Mail Centre which serves the Postcode carried by those Parcels and which are sorted by you to c.86 selections based on Postcode Areas

Our Services offer different prices (referred to as "Charges") according to the machinability of your Mailing Items. All Services enable you hand over Mailing Items for delivery anywhere within the United Kingdom.

- 4.1.2 Figure 1 in Section 2.2: Parcels Services Summary shall be amended as follows:

4.1.4 Figure 10: ‘Format + service split’ in Section 5.2 shall be deleted in its entirety.

4.1.5 Section 5.3 shall be amended as follows:

5.3 Step 3: Weight Band Segregation

If you post Mailing Items of varying weights, Mailing Items must also be sorted into the correct weight band – either 0-1kg or >1kg-2kg.

4.1.6 Figure 11: ‘Format + service + weight band split’ in Section 5.3 shall be deleted in its entirety.

4.1.7 Bullet point number ‘8’ at Section 7.3 shall be deleted in its entirety.

4.1.8 Bullet point number ‘9’ at Section 7.3 shall be amended as follows:

8 Selection Description – *This field defines the Postcode group within the Container and this information can be obtained from the CFL database.*

4.1.9 The first of the two tables which appear at Section 7.9 shall be deleted and replaced with the following;

4.1.12 Paragraph 1 of Appendix C: Unwrapped Specification shall be amended as follows:

1. Introduction

It is possible for us sometimes to accept Mailing Items without wrapping or envelopes. Typically this method of presentation is suited to magazines or catalogues.

4.1.13 Paragraph 1 of Appendix E: Key National Posting (KNP) shall be deleted and replaced with the following:

1. Introduction

The information in this document is designed to define the process for managing together KNP; it describes the communication channels, the flow of information and the actions required by each link within the process.

This process applies to all Mailing Items and is in addition to and does not replace any existing processes for handling Mailing Items as described in this User Guide. The effectiveness of a KNP is largely dependent on the timeliness of the exchange of key information between you and us.

Appendix B: Access Selection Files

Obtaining a copy of the Access Selection Files

Selections for our Services are derived from our Access Selection Files which are available free of charge in a number of computer formats from the Technical Helpline on 0207 371 3727. It can also be downloaded from our Website www.royalmailwholesale.com.

Using the Access Selection Files

The Access Selection Files provide the key data to enable you to sort your Mailing Items into 70 Selections. The Access Selection Files contain data only and not software. You will need to write some software to sort your Mailing Items, or purchase a tailor-made product from a software supplier. A list of suppliers can be found on our Website www.royalmailwholesale.com

What are 70 Selections?

70 require Mailing Items to be sorted into Selections based on Postcode Areas. The Access Selection Files contain around 86 of these Selections.

Standard Selection Codes (SSC)

Each Selection in the Access Selection Files is allocated a unique numeric code – the Standard Selection Code (SSC). The main purpose of the SSC is to identify service level Selection for computer sorting and for Container label identification. A 70 Selection Code has a three-digit SSC (this may be expressed as a 5 digit SSC with two additional '00')

Mailing Items need to be sorted to the 3 digit Selections contained in the Access Selection Files.

Updating the Access Selection Files

The Access Selection Files are updated periodically to reflect any Postcode changes. By downloading the Access Selection Files from our Website you will be automatically added to a circulation list informing you of changes. You will be advised of changes and the arrangements for implementing updates. It is your responsibility to ensure that you implement these changes and that the current version of the Access Selection Files is used.
