## FORECASTING ADJUSTMENT CHANGES TO THE ACCESS LETTERS CONTRACT

Dear Customer,

Continually improving the efficiency of our operation to enable us to provide the best possible service to customers is a priority for Royal Mail. Key to this is having a clear understanding of the workload we need to handle such that we can resource accordingly.

Our Access Letters Contract requires customers to provide a forecast by format (Machineable Letter, Machineable Large Letter, Manual Large Letter) by Mail Centre each day. Customers have a tolerance of either 1000 items, or 15%, whichever is the highest. An adjustment charge can be applied in the event of a customer over forecasting outside of tolerance.

The current charge for this over forecasting is £30.27.

We have reviewed the cost of such over forecasting with customer data from the previous 12 months, looking at the average rate of variation to tolerance, and the current charge is not reflective of the costs incurred. We will, therefore, be amending the charge from  $11^{th}$  October 2021 to £55.00 for each of the four formats.

We are keen work with customers to understand what else can be done to improve forecasting and would welcome suggestions from customers as to how best to progress such engagement. On 16<sup>th</sup> August we will be meeting with the SMP & Carriers working group as a first step.
